In Hollywood Santa Monica, We Vote!

ne of the greatest American responsibilities and duties is to cast a vote. In the year that we celebrate the 100th anniversary of the passage of the 19th Amendment to the Constitution (guaranteeing women the right to vote), let's commit to exercising our rights thoughtfully and responsibly!



Voting safely during a pandemic may seem overwhelming, but we can cast a vote in ways that minimize risk to our health. Although Election Day is Tuesday, Nov. 3, most voting advocates are encouraging citizens to avoid the crowds and the lines by voting early.

For persons who qualify, voting by mail is the safest option. Mail-in ballots should be requested immediately, and the deadline for returning a ballot by mail is Oct. 23. An alternative is to vote during the early voting period, extended by Gov. Abbott this year to Oct. 13-30.

Whenever you vote, please take a moment to preview your ballot and make choices ahead of time. The ballots are twice as long this year (ranging from 28-66 pages), and straight-ticket voting is not allowed. More new and infrequent voters (hurray!), as well as new, unfamiliar voting machines will likely slow things down.



BULKY TRASH PICKUP is on the MONDAY of third full week.

Violations are punishable by fines between \$50 - \$2000 for the 1st citation, and \$100 - \$2000 for the 2nd in a 24-month period. Anyone can report code violations to 311.

SEPARATION ANXIETY IN DOGS

What is it? - Pets acting anxious, destructively or vocalizing when away from their people.

Examples - Your dog chews up the rug and urinates in your house whenever you go to work. The neighbors complain your dog cries constantly whenever you have to run an errand. Your dog looks on the verge of a panic attack when you get ready to leave for the day.

What causes it? This is a mix of dog brain chemistry and life experiences. If your dog is too tightly bonded to you without enough independence skills, then your dog is at risk. This is why it is vital for puppies to learn to have "alone" time. It is also why every dog needs to be able to settle and not be touching a body part of ours the entire time we are home. Dogs that were rescued and then hyper-loved by the new families are at risk. Certain high strung dog breeds are also more prone to issues. Dogs that have a major change like 2 parents at home and children all day long to everyone going back to work/school are at risk. (sound familiar???)

Should I feel Guilty? Is is hard that loving our dogs too much can make them depend on us like we are a drug to them. When I was pregnant with my first child, I created a codependent separation anxiety filled dog in my own household. I am a vet and "know" better. I spent entirely too much time snuggling with him on the couch and not enough time letting him be a dog. As the human, I should determine when it is love time and when it is work time. So, if you feel guilty - I am here to tell you that you are not alone.

Why do I care - With Covid, I am home all the time? One day you may go back to the office, Eventually, there may be a new routine, or a child in your life that necessitates your dog being able to survive periods of time on his own. It is much easier for this to always be a part of his life rather than a rude shock one day.

Uhhh- my dog is already overly needy - what do I do?

- Teach a Settle Command. This means go to bed and stay there until I release you. Your dog should be ok sitting or sleeping on her bed at your command while you work or cook or watch TV. Practice this every day with the end goal of 1 hour a day in dog nap zone. You may need to start with 10 seconds.
- Start a nothing for free program. Do not let your dog dictate when the attention nozzle flows freely from you. They should always do a trick or other command prior to attention being delivered. This helps them build confidence and lets you titrate out the attention. Dogs that constantly hit your hand for you to rub them NEED this lesson.
- Desensitize your pet to you leaving the house. Gather keys, purse, open the garage door, and then DO NOTHING. Sit back down. Repeat frequently until your dog stops getting super stressed by the actions.
- No leaving drama or returning drama. DO NOT kiss your dog like it is the last time you will ever see her prior to leaving. And then don't just overwhelm her when you get home. It is better to have a quiet goodbye and IGNORE them for a few minutes after you return. They have waited hours to go potty- they can wait another 5 minutes while you ignore them. This reduces the hot / cold experiences for them of you being there versus being gone from home.
- Ask your veterinarian for other tips and medications in extreme cases. Know there isn't a magic pill and you will not get out of the need to train if these problems are in your household!

EXPANDED NEIGHBORHOOD PATROL (ENP) UPDATE

Protect Yourself Against Car Jacking

ur neighborhood reported crime events continues to be low, with burglary of a motor vehicle and theft of a motor vehicle the most serious. This is not the same for some of our surrounding neighborhoods. Thank you to our Officers for the continued patrol and presence.

This year has been unusual in many ways! We think differently every time we leave the house. One of the crimes that has caught the American public's attention in the past two decades is "Car Jacking". Legally speaking, this is classified as Robbery (or Aggravated Robbery, if a weapon or threat of a weapon is used by a criminal against a victim), but it is often referred to by the public as "Car Jacking".

Understanding Car Jacking from a Criminal's Viewpoint:

- Modern vehicles are often equipped with ignition systems
 requiring a coded key to start the engine. These vehicles are very
 difficult or impossible to "hot wire", and sometimes the only way
 to steal a vehicle (outside of towing) is to steal the ignition key
 from the vehicle's operator.
- Thieves, often traveling in groups and in a vehicle, will eye a
 vehicle they want. "Impulse shopping" at its very worst, they will
 approach a vehicle at an traffic signal, in heavy traffic, or when
 a vehicle operator is entering or exiting a vehicle, and steal the
 vehicle. Often, these thieves use a weapon to secure control of
 the situation and take the vehicle.
- Gas stations and car washes are often the venue for a car jacking.
 Vehicle operators are distracted attending to their vehicle, and easily surprised by criminals.
- Criminals often watch ATM machines, especially drive up and drive through locations, and often at night. In many cases, criminals are able to rob victims of the cash they withdraw from the ATM as well as steal their vehicle.
- Shoppers loading packages into a vehicle are often targeted because they are distracted. A thief may escape with both the vehicle and the packages being loaded.


What You can do to help prevent from becoming a victim:

- Leaving Parking: Park your vehicle in a well-lit area, clearly visible to the public. An attended parking lot is ideal, as criminals hate having witnesses.
- Entering Your Vehicle: have your keys in your hand, ready to enter. Keep your eyes moving and your head "on a swivel"; know your surroundings. Trust your instincts: If you "feel" something is wrong, turn around and leave the area. Once your reach your vehicle, unlock, quickly enter, then re-lock the doors. Get the vehicle moving as soon as you can.
- Be wary of people near your vehicle ask for directions, or ask for money to help with gas ("I'm from out of town and lost my

- wallet..."), or other possible distractions. They may be working with a partner, who will attempt to take your keys, and your vehicle.
- When in your vehicle and driving, keep your doors locked, and your windows rolled up.
- Drive in the center lane of a street (away from curbs and sidewalks)
- When stopping in traffic at a stop sign or stop signal, make sure you have room in front of you to maneuver and escape, if necessary. Rule of thumb: If you can't see the rear tires of the vehicle in front of you touching the pavement, you're too close.
- **Keep your cell phone in your pocket.** If your vehicle is stolen, you will have a way of contacting 911. If you cell phone is left inside the vehicle, you're stranded without a way to call for help.
- **Keep your head on a swivel**, and your eyes moving; be aware of your surroundings. Often, if a criminal senses that a victim has observed him ("made him"), they'll look for an easier victim.
- Be aware that some thieves will "bump" a vehicle from behind, and steal a victim's vehicle when the victim stops to exchange information. Signal to the other vehicle's driver to follow you to a well-lit public area to exchange information. If you see a fire or police station, stop there and summon aid from inside.
- If you are a victim of Carjacking, cooperate with the suspect. Give him what he wants, and don't argue. Make a mental note of the suspect(s) description, their vehicle's description (if they have one), and report to 911 as soon as possible. Your safety, and your life, are far more important than a car.

Remember that YOU are an important partner in the fight against crime.



HOLLYWOOD/SANTA MONICA IS A CONSERVATION DISTRICT

Ordinance No. 21608 Adopted March 9, 1993.

ANY construction or remodeling of the outside of your home requires a Conservation District Work Review Form from the City of Dallas. This form is in addition to any other permits (such as building permits) required by the city.

GET YOUR CONSERVATION DISTRICT WORK REVIEW FORM BEFORE YOU BEGIN EXTERIOR REMODELING, REPAIRING, OR IMPROVEMENTS TO YOUR HOME.

In a Conservation District, the guidelines are city law, and violations result in the city enforcing the Conservation District Ordinance with work stoppage or fines. You can download a copy of the ordinance on our website at www.hsmna.org. The process to obtain a Conservation District Work Review Form is painless and can be done by mail. Before you begin work on the outside of your house, send a detailed description of what you plan to do with photos of the existing area and sketches of your proposal to:

CONSERVATION DISTRICT SUBMITTAL REQUIREMENTS

The documentation listed below must be submitted with a completed Conservation District Work Review Form Application. By checking each requirement you are stating that you have supplied correct and complete information. In the event that the required information is not contained in the submitted documents, you will be notified. Failure to supply the requested information will result in the review of your application being delayed.



REMODELING/ADDITIONS AND NEW CONSTRUCTION

TWO Sets of plan drawings including:

- **Elevations.** (labeled north, south, east, & west as applicable) and plan drawings to scale indicating proposed alterations or additions, clearly delineating existing and proposed work. Note: until further notice, an 11" by 17" set of plans must be provided in addition to the full-sets.
- **Site plan.** Provide a site plan that shows the location and dimensions of any additions and/or new construction and all setbacks.
- **Survey.** Provide a copy of the survey of the lot that shows: 1) dimensions of lot, 2) location and dimensions of existing structures; and 3) all setbacks.
- **Photographs.** Provide photographs of house and/or other structures on property where work is to be done. Photos should clearly show existing conditions (where work is proposed) from all relevant sides.
- Grading plan. If the existing slope of the lot is being altered, provide a grading plan.
- A scalable detail drawing of the proposed foundation at a min. scale of $\frac{1}{2}$ -inch = 1-foot. Foundation detail should indicate location of finished grade.



WINDOWS

- Photographs of all windows to be replaced.
- Manufacturers' image(s) of proposed new windows. Image should clearly show the dimensions of the windows, the number of lites/divisions, whether muntins are expressed outside of the class, window material and window types (double hung, casement, etc.)

 Paint color chip required. Color chip should show brand, color number and name (e.g., Sherwin-Williams. SW 6359, Beige).



- A section through the length and the width of the pool/spa showing the height (in inches) above grade for any element of the pool and/or spa above grade.
- An 8.5 by 11 color image of how the finished pool/spa will look.



FENCES

A property survey clearly showing the locations of existing/proposed fencing, existing/proposed materials and existing/proposed fence heights.

NOTE: Submittal requirements for fences may vary according to Conservation District regulations additional drawings and information may be required to complete project review.

NOTE: Minimum scale of 1/8"=1'0" on all plans and elevations, unless otherwise approved by a Conservation District Planner. Plans should not be reduced and must be to scale to verify measurements. Section and/or detail drawings if required should have a minimum scale of $\frac{1}{2}$ " = 1'.

What do you love most about this neighborhood?



BIG IMPROVEMENTS COMING TO LINDSLEY PARK



hanks to our Council Member David Blewett and Amanda Shultz - District 14 Dallas Park and Recreation Board, our beloved Lindsley Park will be undergoing some major renovations that will be ready by Spring 2021. Improvements that total \$120,000.00, include replacing the existing playground installed in 1993 by the HSMNA with brand new all abilities playground equipment, sidewalk repairs and permanent restroom facilities. Pavilion, perimeter and interior park lighting will be upgraded to state-of-the-art LED fixtures that minimize glare while reducing light trespass and skyglow so not to impact adjacent neighbors.

Construction is planned to start January 2021 and be finished by the Spring, weather permitting. Look for future updates on the progress and be patient when the dirt starts flying. When completed, this will be another jewel added to our gem of a neighborhood.

UNIVERSAL PEDESTRIAN AND CYCLIST ACCESSIBILITY FOR HOLLYWOOD SANTA MONICA

n September, the HSMNA Board acted decisively to ensure that an all-weather accessible sidewalk, programmed by the City, was constructed to connect our HSMNA students to J.L. Long and Woodrow Wilson. Not only are able-bodied students no longer required to walk or bike in the middle of Santa Fe, but disabled persons and cyclists now have an accessible path to the schools.

Associated with this project were two curb cuts on the southeastern and southwestern quadrants of Santa Fe and Monte Vista. Mobility impaired Hollywood residents able to get to Monte Vista can get to the new Woodrow/Long sidewalk. See photos below.

So what is the bad news? First a bit

of background. Too many corners in HSM have no curb cuts at all, forcing elderly and disabled persons to access and egress sidewalks via driveways. Any unpaved surface or blocked sidewalk is a barrier to accessibility under the Americans With Disabilities Act.

Though we love our trees, they heave up sidewalks and create barriers. Our native swelling clay divides sidewalks at the cement joint, thrusting one side up. Finally, insensitive utility companies have located utility poles right at street corners and cut off wheelchair access even where wheelchair ramps exist.

Fairness to elderly and HSM persons with disabilities is a moral issue, but provides benefits for us all. Due to Covid, the neighborhood is experiencing

a "walking revolution". Our walkers, particularly older ones, should be able to choose fully accessible sidewalks, especially at night when streets can be hazardous Young (and older) cyclists should be easily able to exercise their legal right to use sidewalks without bumping up and down raised curbs.

If you doubt the need, just take a walk over to the Lakewood shopping Center to see what barriers await you as you travel to what is perhaps our neighborhood's main travel attractor. Imagine being in a wheelchair. It is time for us to build on recent successes and work with our HSMNA Board and City to modify sidewalks to build a universally accessible Hollywood/Santa Monica.

THE HISTORY OF THE HSM TRIANGLES AND THE MONUMENT ENTRANCE GARDEN

s Historian I was trying to find a fun ghost story to write about for the October Newsletter, but a more important story presented itself. I am also a volunteer on The Landscape Committee and this history of our Triangle parks has been in the works for some time, with the help of several neighbors that were involved in the planning and execution of our parks,



providing photographs, the original plans and list of donors, this is the story.

The Hollywood

triangle movement began in early 1995 with the Mistletoe triangle which then consisted of a large grassy lawn, a postal storage box, and a large creosote pole with a streetlight (see photo). Rob Parks, Jason and Rebecca Barnes, John Lill, and David Donohue approached the HSMNA Board about the idea of landscaping the triangle. The Board authorized these neighbors to proceed, and the group worked to conclude

a "Mowmentum Agreement" with the City of Dallas allowing HSMNA to landscape the space subject to tight restrictions.

The City required a landscape plan before it would approve the



agreement, and the group contacted celebrated landscape architect Naud Burnett to develop the plan, which was produced in February 1995. That plan, shown in a photo against the background of today's triangle, was submitted to the City and attached to the agreement. Though ad hoc alterations have been made to the Naud Burnett planting plan, that plan remains the basis of our agreement with the City, with any subsequent changes requiring an updated plan.

The plan included replacing the original creosote light pole with an antique-looking "acorn light" for which the neighborhood paid \$1000. In the photo, the triangle is



shown after the installation of the acorn light, but before the landscaping began.

Though Naud Burnett worked pro bono, the plan's implementation was beyond the means of the HSMNA alone.

In the photos are two views of the Mistletoe triangle's opening day. In the closer shot are David Donohue, John Lill,



Parks, along with an unnamed canine triangle founder. Asked recently to

and Rob

comment, John Lill said, "It feels good to be part of a neighborhood improvement. I put down a lot of flagstone sidewalk."

Jason Barnes added, "I built and installed the birdbath. I hadn't built one that big before, nor did I do it again. I was very worried someone would steal it for the

copper, so I sank that big steel pipe filled with concrete for a strong connection to the copper bowl." Happily, the cooper birdbath and steel pole have survived several subsequent attempts to steal it.



Another photo shows the newly placed Oklahoma flagstone, some of the first plantings, and original Chinese Chippendale style benches a neighbor later replaced with concrete cemetery benches. Other neighbors, including Rob Parks and Charles Ladymon, watered the triangle until the installation of the sprinkler system, keeping the plantings alive. Mr. Parks is said to have had the longest hose in Hollywood! This spring, the relocation of the existing Charles Ladymon/Morris Granton Memorial Plagues was completed as well as the relocation/

renovation of the concrete benches by the Landscape Committee: Rob Parks, Jennifer Near, Ricky Garson, Judson Stafford and assistants

Ed Zahra, Arthur Gonzales. In addition, the Landscape Committee had the heritage pecan, inspected and treated by a certified arborist. The arborist also checked the health of all the other trees in all of the parks.

The Mistletoe triangle inspired the development of the Clermont/San Mateo upper triangle. The photo shows that triangle before it was landscaped. The

ugly creosote pole that accumulated makeshift signs was replaced by today's acorn light, with the wire connection being put underground. The photo also shows the weed tufts which were the only "landscaping" at the time.

The group discovered that another triangle (one block down the hill on Clermont) had been paved over by the City. They were able to get it disinterred for landscaping. It is an impressive feat to get a utility company to underground overhead wires, but convincing a Public Works Department to "daylight" what it had paved over and restore it with curbs was pretty amazing, even with the help of our then council person.

By this time, the Hollywood landscaping movement had taken on a life of its own, and another Team Hollywood group began the ambitious Monument Garden, perhaps the most impressive and certainly the most expensive project of them all. The Monument Garden merits a whole separate submission in the future, so stay tuned!

We cannot be sure where the Hollywood "landscaping movement" will take us in the

future, but it is unlikely it's just confined to the past. At some time in the future, the triangles will need to be refurbished,

including even the Monument Garden. Adding more pollinator friendly plants for the children of HSMNA to enjoy butterflies and bees, making sure the trees are healthy for years to come, resetting the flagstone so that it is more level and safer is just some of the long-term plans for all of our neighborhood parks.

As we await the future, please take this COVID time to walk or bike to our triangles



with the "before" photos in hand. Take the time to thank the neighbors still with us who participated in the planning, construction. watering, and maintenance of the triangles, and reflect for a moment on

those helpers no longer with us, their spirits are within our parks.
